STALL APPLICATIONS FOR THE LAUREL FALL MEET ARE DUE AUGUST 17TH..

Attention Trainers: The four stakes on August 22, will have a purse of \$60,000 instead of \$50,000. They are the Md. Bred OR Md. Sired stakes.

STARTING AUGUST 1ST, THERE IS A NEW SHOE RULE FOR THE TURF COURSE. ONLY FLAT, QUEEN'S PLATE, QUEEN'S PLATE XT, SILVER QUEEN'S AND FACTORY WEDGE SHOES WILL BE ALLOWED ON THE TURF COURSE. THE DIRT COURSE REMAINS THE SAME AS BEFORE.

Starting August 1st, the regulation establishing a threshold for COBALT will be effective. Any horse whose blood specimen is found to exceed 25 nanograms per milliliter of blood plasma or serum shall be considered a positive finding.

The races on August 22 in the condition are for Maryland Bred horses OR Maryland Sired horses.

Horses will not be tattooed unless you have a slip from the horsemen's bookkeeper stating that you have paid first.

ALL TRAILERS AND HORSE VANS THAT ARE PARKED BEHIND THE RACING OFFICE, MUST BE MOVED TO THE DESIGNATED AREA ON THE HOWARD COUNTY LOT BY AUGUST 10TH. DO NOT MOVE THEM TO THE STABLE AREA. YOU MUST ENTER THE HOWARD COUNTY LOT OFF OF ROUTE 1. ANY VEHICLE THAT IS NOT MOVED BY AUGUST 10TH WILL BE TOWED.
